Personal / Family

1. Learn about your family's history and philanthropic legacy
2. Write, video, or somehow record that history and legacy
3. Learn what the family foundation means to each family member
4. Articulate the values that inform your philanthropy
5. Develop a personal giving plan
6. Write a personal check to an organization about which you care passionately
7. Find a seasoned funder (outside of your family) to serve as a mentor
8. Offer to mentor a younger funder
9. Figure out the role you want to play in your family foundation
10. Keep a journal of your philanthropic journey
11. Work with older generation family members to develop a succession plan
12. Think about what kind of change you want to see in the world and how philanthropy can be a part of that

13. Attend a family foundation board meeting
14. Read through the foundation's charter and bylaws
15. Meet and get to know each member of the foundation's staff or team of advisors
16. Log onto www.boardsource.com to learn more about board member responsibilities
17. Develop an agenda for a board meeting with the board Chair
18. Volunteer to facilitate a family foundation board meeting
19. Plan a family foundation retreat
20. Ask critical questions about foundation policies
21. Work with your board to create young people-friendly policies

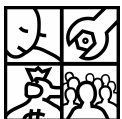
23. Meet with your foundation's investment advisors and money managers

29. Read about the 5% minimum payout obligation and ask about your foundation's payout rate
30. Read at least one grant proposal and present it at the foundation meeting
31. Learn how to read operating and project budgets
32. Conduct a site visit to one of your foundation's grantees
33. Volunteer for a non-profit organization
34. Offer to serve on a non-profit board of directors
35. Recommend a grant to your family foundation
36. Write a grant request to understand what it entails
37. Learn to say "yes" and "no" to grant requests
